**Key/Pier Spaces**

For owners with boats, pier spaces are available at an annual cost of \$50.00 per side. Because space is limited, registration is on first come, first serve basis but 2017 pier users have first right of refusal. This right expires May 31, 2018. (See below for a boat ramp key and / or pier space requests.)
